Thank you for entering K-9 OTC's agility trial; except for the first classes of the day, all start times are approximate.

If you are willing to help set up for the trial, the building will be available for crate setup Friday night at 4 PM.

The building will open Saturday/Sunday at 6:30 AM. Parking is available in the Think Pawsitive lot; no street or overnight parking allowed. Food will not be available on site, but there are fast food options nearby.

Volunteers: Trials cannot function without volunteers! Volunteer sign-up can be found by clicking on the VOLUNTEERS link at www.agilgold.com. Volunteers will receive lunch, drinks, and snacks.

Crating space is available in two rooms: one with AC and one without. Crates may be left overnight; dogs may not. K-9 OTC & Think Pawsitive LLC will not be responsible for any lost or damaged items left at the show site. Dogs with space issues must be covered and non-disruptive. All sides of the crate/xpen must be closed.

Air conditioning is not yet installed in the ring/crating area; please plan accordingly. Battery operated fans only.

PICK UP AFTER YOUR DOGS! Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions.

Measuring: The Trial Secretary is a Volunteer Measuring Official (VMO). *If your dog needs to be measured, please be available at least 1 hour prior to your first run.*

Directions: Remember to follow detour routes and allow for construction.

From the North:

Take US-41 S toward Milwaukee. Merge onto I-94 W via EXIT 38B toward Madison. Take Exit 297 for US-18/Barker Rd toward Cty Rd JJ/Bluemound Rd. Keep Left at the fork; follow signs for County Highway Y South/Barker Rd. Continue on N Barker Rd. Slight RIGHT onto WI-59W/W Greenfield Ave. Use any lane to turn LEFT onto WI-164 S/WI-59 W. Turn RIGHT onto Pearl Street. Turn LEFT onto Commerce Street. Turn LEFT at the dead end. There is a large 301 on the building; turn RIGHT for parking in the rear or go straight and up the ramp for parking in front.

From the South:

Take I-94 W/US-41N toward MILWAUKEE. Use the two right lanes to take EXIT 317 toward I-43S/894 Bypass/Madison. Continue on I-43 S/I-894 W. Take EXIT 4 for I-43 S/US 45 S toward Beloit. Take EXIT 54 for Racine Ave. Turn RIGHT onto S Racine Ave. Turn RIGHT onto WI-164 N/WI-59 E Les Paul Pkwy. Turn LEFT onto Pearl Street. Turn LEFT onto Commerce Street. Turn LEFT at the dead end. There is a large 301 on the building; turn RIGHT for parking in the rear or go straight and up the ramp for parking in front.

From the West:

Take I-94 E. Take EXIT 297 to merge onto US-18 W/WI-164 S/E Moreland Blvd. Use the two left lanes to turn LEFT onto WI-164 S/Les Paul Pkwy. Turn RIGHT onto Pearl Street. Turn LEFT onto Commerce Street. Turn LEFT at the dead end. There is a large 301 on the building; turn RIGHT for parking in the rear or go straight and up the ramp for parking in front.

Hotels: Please double check with the hotel regarding their policy to accept dogs as this is subject to change.
