

Doberman Pinscher Club of Greater Milwaukee AKC Agility Trial

Thank you for entering the **Doberman Pinscher Club of Greater Milwaukee's agility trial**.

This trial will be held in compliance with COVID-19 state and local public health guidelines. The COVID-19 waiver that you signed is still valid! We trust that each person will adhere to the guidelines set forth. *Non-compliance will result in the forfeiture of your entry and excusal from the trial.*

If you are ill or have been in contact with someone with COVID-19 in the last 14 days, or if you or someone in your home has had symptoms in the last 24 hours, STAY HOME!

For the safety and well-being of all in attendance, <u>a face mask that covers the mouth and nose</u> is required at all times while in the building, and outside when social distancing is not possible. A face mask that covers the mouth and nose MUST be worn during your run. Face shields must be used in conjunction with a mask. If you do not have an appropriate mask, one will be given to you.

Only club members, Workers, and Handlers entered in the event will be permitted in the building.

- Please practice social distancing consistent with current guidelines (minimum 6').
- ₩ Wash hands as frequently as possible with soap for a minimum of 20 seconds.
- No dogs allowed in bathrooms. Bathrooms will be wiped down between each class.
- Avoid touching and giving treats to dogs that are not your responsibility.
- Hand sanitizer dispensers will be placed in strategic areas and there is soap in the restrooms.
- High traffic/touch areas will be cleaned throughout the day.
- There will be NO pens or markers available; please bring your own.
- Chairs will NOT be available inside or outside the ring; please bring your own.
- Please be respectful of Exhibitors working out of their vehicles. Allow space to get their dogs in and out.
- We apologize but there will be no food/drinks for workers on site. Please plan to pack/bring your own.
- No MACH/PACH cakes allowed.

There is ONE ENTRANCE DOOR and ONE EXIT DOOR from the ring. See Site Map on p. 4.

PARKING: Think Pawsitive has 3 lots (front, back, side). We ask that **Workers unload using the back lot and use the front or side lots to park**. If you will be working out of your vehicle, please use the back lot.

- There is no shade in any of the parking areas. Please bring fans, reflective mesh, etc.
- Please remember to maintain social distancing of at least 6'; avoid shaking hands or hugging.
- Due to limited parking, there will be start times for each class. Please do not arrive early.

Workers/Crating Space: Indoor crating space is reserved for workers and members of DPCGM in the BLUE crating room.

- Volunteer sign-up can be found by clicking on the VOLUNTEERS link at www.agilgold.com.
- Be sure to maintain 6' spacing.
- Please bring your own chair.
- DPCGM & Think Pawsitive LLC will not be responsible for any lost or damaged items left at the show site. Dogs
 with space issues must be covered and non-disruptive. All sides of the crate/xpen must be closed.
 Please bring your own food/water/drinks; there are fast food options nearby.

Course Maps – No printed copies of course maps will be provided.

- Maps will be available online Friday night as well as posted outside and near the crating area.
- Maps for the next day will be available online after 6 pm at www.agilgold.com.

Gate Boards will be posted on an outside wall for Exhibitors to check in. Exhibitors must use their own pen/marker.

The Judge's Briefing will be posted. In person Briefings will only be held for Open and Novice classes.

Measuring Dogs: Only Novice and Open dogs that need their 1st official measurement to verify jump height will be measured. If your dog needs to be measured, please speak to the trial secretary when you arrive.

Walk-thru group sizes will be limited to no more than 25 people.

Leashes/Harnesses – <u>We will not be using a leash runner!</u> Because of the ring layout, AKC has given DPCGM an exemption.

- Handlers may pocket or wear their leash while running the course.
- Handlers who use a harness may have one assistant who, upon you entering the ring, will take the harness to the exit for you.

INDOOR RING PROCEDURE: see map p. 4

There will be 2 gate stewards – one at the back-entry door and the other at the ring entrance. We should have 7 teams in the building at a time.

- When you are called, wait at the door, then proceed to the practice jump (when open).
- When you are warmed up, please continue to the line-up chute.
- Maintain social distance and control of your dog.
- Once you enter the ring, pocket/wear your leash or hand harness to your assistant.
- Once you are done competing, we ask that you quickly leash/harness your dog, exit the building, and return to your vehicle (crate area for workers).

RESULTS/AWARDS

- Results will be posted on an outside wall as a jump height/class is completed, and the Judge has verified results. Individual results will be emailed to you later that day and at the end of the trial.
- Ribbons & Stickers will be distributed by a DPCGM Committee Member only (no self-serve).
- Exhibitors will be given the option of receiving just their sticker OR their sticker and applicable ribbon(s).
- Once you are done competing and have your results/awards, we ask that you leave the premises to make room for the Open and Novice classes that follow later in the day.

PICK UP AFTER YOUR DOGS! Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember, hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions.

If you have concerns with the effectiveness of our new policies & procedures or need to report a violation, please talk with a DPCGM club member. They will bring it to the DPCGM Trial Committee for review.

Preliminary Running Order based on move-ups not yet received. Running Order within each height will be: Master, Master Preferred, Exc, Exc Preferred, Open, Open Preferred, Novice B, Novice A, then Novice Preferred.

Walk-thru sizes for the Excellent classes will be limited.

Master/Exc 24/20" jump height will have 1 walk-thru; 16-4" will have 2 walk-thru's.

Because of small class sizes, Open and Novice exhibitors should arrive by noon.

Please do not enter the building until the previous jump height/class is finished.

Directions: Remember to follow detour routes and allow for construction.

From the North:

Take US-41 S toward Milwaukee. Merge onto I-94 W via EXIT 38B toward Madison. Take Exit 297 for US-18/Barker Rd toward Cty Rd JJ/Bluemound Rd. Keep Left at the fork; follow signs for County Highway Y South/Barker Rd. Continue on N Barker Rd. Slight RIGHT onto WI-59W/W Greenfield Ave. Use any lane to turn LEFT onto WI-164 S/WI-59 W. Turn RIGHT onto Pearl Street. Turn LEFT onto Commerce Street. Turn LEFT at the dead end. There is a large **301** on the building; turn RIGHT for parking/unloading in the back.

From the South:

Take I-94 W/US-41N toward MILWAUKEE. Use the two right lanes to take EXIT 317 toward I-43S/894 Bypass/Madison. Continue on I-43 S/I-894 W. Take EXIT 4 for I-43 S/US 45 S toward Beloit. Take EXIT 54 for Racine Ave. Turn RIGHT onto S Racine Ave. Turn RIGHT onto WI-164 N/WI-59 E Les Paul Pkwy. Turn LEFT onto Pearl Street. Turn LEFT onto Commerce Street. Turn LEFT at the dead end. There is a large **301** on the building; turn RIGHT for parking/unloading in the back.

From the West:

Take I-94 E. Take EXIT 297 to merge onto US-18 W/WI-164 S/E Moreland Blvd. Use the two left lanes to turn LEFT onto WI-164 S/Les Paul Pkwy. Turn RIGHT onto Pearl Street. Turn LEFT onto Commerce Street. Turn LEFT at the dead end. There is a large **301** on the building; turn RIGHT for parking/unloading in the back.
